## E-COMMERCE MERCHANTS

THEY MENTION THAT THE CERTIFICATES ARE ONLY VANITY CERTIFICATES AND DO NOT HOLD ANY ACTUAL VALUE. MANY VANITY DEGREE WEBSITES ARE ALREADY USING ECHECK.
