

Prohibited Business Types | These business types are not supported by our payment processing partners. Please note that the list is not exhaustive.

Child Pornography | Any business which hosts and/or creates and/or helps distribute child sexual abuse images, videos, or content including “pseudo images” of a child which can either be a cartoon or CGI (e.g. hentai where the images are clearly childlike and not adult).

Bestiality | Any business which hosts and/or creates and/or helps distribute content depicting sex with an animal or the performing of sexual acts on and/or while touching animals in any way.

Necrophilia | Any business which hosts and/or creates and/or helps distribute content depicting sex with a dead body or any sexual act performed on or near a corpse.

Forced Sex and/or Rape | Any business which hosts and/or creates and/or helps distribute content depicting non-consensual sex and/or any sexual act being performed by one or more parties without the consent of all parties. This includes subjects who appear asleep or unable to give consent through use of drugs and/or alcohol as well as any content shared without the apparent consent of the subject of the video(s) and/or image(s).

Violence and Humiliation Any business which hosts and/or creates and/or helps distribute content depicting violent acts including acts which will leave scars or permanent marks.

Hate Mongers | Any business which hosts and/or creates and/or helps distribute content and/or products promoting racism and/or sexism and/or xenophobia and/or hate against a particular group.

Cruelty Against Animals | Any business which hosts and/or creates and/or helps distribute content and/or products promoting and/or facilitating in acts of cruelty against animals. This includes any form of media depicting acts of cruelty being carried out on animals whether classified as ‘sport’ or not.

In addition, we include in this category any business selling: snares, gin traps, fenn traps, cage traps or any other type of trap which could result in suffering being inflicted upon any animal, as well as electric shock collars or any other device which can produce an electrical charge which could be used on an animal (e.g. cattle prods).

IP Violations | Any business which hosts and/or creates and/or helps distribute content and/or products which infringe on the intellectual property rights of others protected under copyright law. This includes businesses which sell fake, replica or lookalike goods.

Multi-Layer Marketing Any business which engages in any form of Pyramid Selling and/or Network Marketing and/or Referral Marketing.

Protected Cultural Items | Any business which sells and/or organizes the sale of items covered under the UNESCO 1970 Convention.

Businesses with Sanctioned Individuals and/or Entities | Any business in which a principle member (director, shareholder, UBO, senior member of staff) and/or associated entity is subject to sanctions under the following lists: OFAC, HMRC, UN Sanctions, EU Sanctions, FATF.

Businesses with Entities from Countries Designated as “Enemies of the State of Israel”

Any business in which an associated entity is incorporated in one of the following countries: Iran, Pakistan, Iraq, Libya, Lebanon, Saudi Arabia, Syria, Yemen.

Businesses with Bearer Shares | Any business whose organisation has bearer shares as a means to show ownership.

Illegal Businesses | Any business which provides access and/or sells services and/or products which are illegal in the markets where the business is operating. This includes any business that must have a license to operate in its country or countries of operation.
